



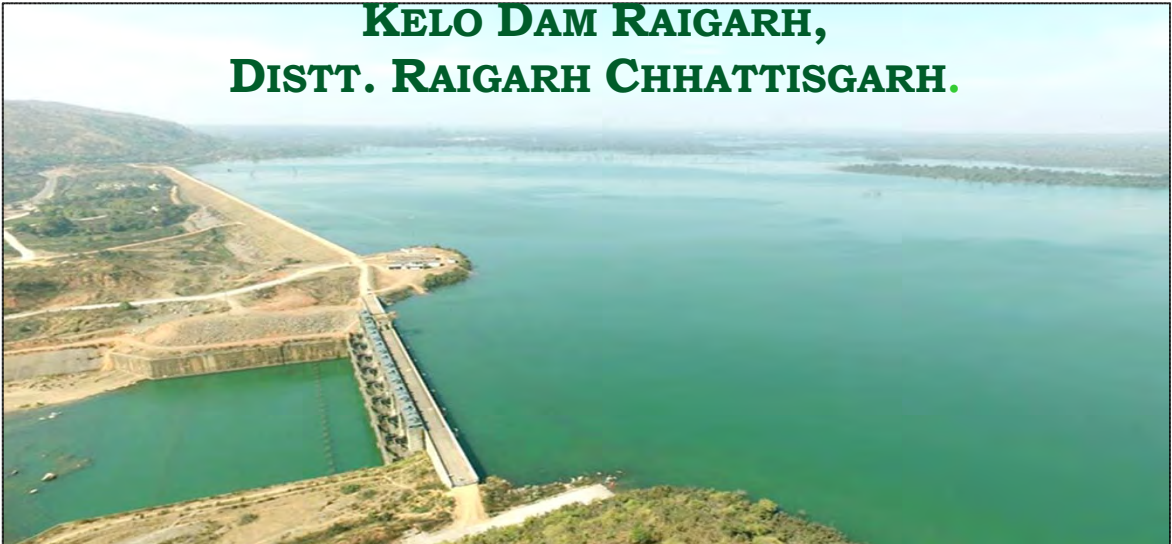

1. The following documents attached hereto shall be deemed to form an integral part of this Contract:
 - (a) The General conditions of contract (hereinafter called "GC")
 - (b) The Special Condition of contract (hereinafter called "SC")
2. The mutual rights and obligations of the **Engineer-in-Charge** and the **Contractor/Agency/Firms** shall be as set forth in the Contract, in particular.
 - (a) The **Contractor/Agency/Firms** shall carry out the works in accordance with the provisions of the Contract, and
 - (b) The **Engineer-in-Charge** shall make payments to the **Contractor/Agency/Firms** in accordance with the provisions of the Contract.

A. GENERAL CONDITIONS OF CONTRACT

1.1 Definition and Interpretation

Unless the context otherwise requires, the following terms whenever used in this Contract have the following meanings:

- (a) “Applicable law” means the law, and any other instruments having the force of law in the State of Chhattisgarh and Government of India, as they may be issued enforce from time to time..
- (b) “Contract” means the contract signed by the parties, to which these general conditions of contract (G.G.) are attached, together with all documents listed in clause I of such signed contract;
- (c) “Contract Price” means the price to be paid for the performance of the work.
- (d) “GC” means these General Conditions of contract;
- (e) “Party” means the **Engineer-in-Charge** or the **Contractor/ Agency/ Firms**; as the case may be, and parties means both of them;
- (f) “Personnel” means persons hired by the **Contractor/ Agency/ Firms** for the performance of the work or any part thereof;
- (g) “Sc” means the special conditions of contract by which these general conditions of contract may be amended or supplemented.
- (h) “Government” means the **Engineer-in-charge** of department.

1.2 **Law Governing the Contract**

This contract, its meaning and interpretation, and the relation between the parties shall be governed by the Applicable Law.

1.3 **Language of Contract**

All literature and correspondence in connection with the contract shall be in English. The contractor shall arrange for translation of Hindi into English in case of correspondence made by the department is in Hindi.

1.4 **Notices**

Any notice, request or consent made pursuant to this contract shall be in writing and shall be deemed to have been made when delivered in person to an authorized representative of the party to whom the communication is addressed, or when sent by registered mail., fax, telegram to such party, at the address specified in the special condition.

1.5 **Location**

The work shall be performed at such locations as are specified in Contract and, where the location of a particular task is not so specified. At such locations, where or elsewhere, as the **Engineer-in-charge** may approve.

1.6 **Authorized Representatives**

Any action required or permitted, to be taken and any document required or permitted to be executed under this contract by the **Engineer-in-charge** or the **Contractor/ Agency/ Firms** may be taken or executed by the officials specified in the SC.

1.7 **Taxes and Duties**

Unless otherwise specified in the SC, the **Contractor/ Agency/ Firms** and their personnel shall pay such taxes, duties, fees and other impositions as may be levied under the Applicable Law, the amount of which is deemed to have been included in the contract price.

2. **COMMENCEMENT, COMPLETION, MODIFICATION AND TERMINATION OF CONTRACT**

2.1 **Effectiveness of Contract**

This contract shall come into effect on the date the contract is signed by both parties or such other later date as may be stated in the SC.

2.2 **Commencement of work**

The **Contractor/ Agency/ Firms** shall carry out the work immediately after the date the contract becomes effective, or at such other date as may be specified in the SC.

2.3 **Expiration of Contract**

Unless terminated earlier this contract shall terminate at the end of such time period after the effective date as is specified in the SC.

2.4. **Modification**

Modification of the terms and conditions of this contract, including any modification of the scope of the work or of the contract price, may only be made by written agreement between the parties.

2.5 **Force Majeure**

2.5.1 **Definition**

For the purpose of this contract, Force Majeure means an event which is beyond the reasonably control of a party, and which makes a party's performance or its obligations. under the contract impossible or so impractical as to be considered impossible under the circumstances, decision of the Chief Engineer, Minimata (Hasdeo) Bango Project, Bilaspur (C.G.) will be final in this regard.

2.5.2 **No Breach of Contract**

The failure of a party to fulfill any of its obligations under the Contract shall not be considered to be a breach of or default under this contract. so far as, such inability arises from an event of Force Majeure, provided that the party affected by such an event (a) has taken all reasonable precautions, due care and reasonable

alternative measures in order to carry out the terms and conditions of this contract, and (b) has informed the other party as soon as possible about the occurrence of such an event.

2.5.3 **Extension of Time**

Any period within which a party shall, pursuant to this contract, complete any action or task, shall be extended for a period equal to the time during which such party was unable to perform such action as result of force majeure.

2.5.4 **Payments**

No compensation will be payable to the contractor for any loss incurred to the contractor due to force Majeure.

2.6 **Termination**

2.6.1 **By the Engineer-in-charge**

The **Engineer-in-charge** may terminate this contract, by not less than thirty (30) days' written notice of termination to the contractor, to be given after the occurrence of any of the events specified in paragraph (a) to (d) of this clause 2.6.1 and sixty (60) days' in the case of the event referred to in (e):

- (a) If the contractor do not attend to remedy for a failure in the performance of their obligations under the contract within thirty (30) days of receipt after being notified or within such further period as the **Engineer-in-charge** may have subsequently approved in writing.
- (b) If the contractor become insolvent or bankrupt;
- (c) If, as the result of force majeure, the contractor is unable to execute the specified work for a period of not less than sixty (60) days;
or
- (d) If the contractor in the judgment of the **Engineer-in-charge** has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

For the purpose of this clause:

“Corrupt practice” means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the selection process or in contract execution.

‘Fraudulent practice” means a misrepresentation of facts in order to influence a selection process or the execution of a contract to the detriment of the borrower, and includes collusive practice among agency/firms (prior to or after submission of proposals) designed to establish prices at artificial non-competitive levels and to deprive the borrower of the benefits of free and open competition.

- (e) If the **Engineer-in-charge** in his sole discretion and for any reason whatsoever decided to terminate this contract.

2.6.2 By the Agency/Firms

The contractor may terminate this contract. by not less than thirty (30) days’ written notice to the **Engineer-in-charge**. Such notice is to be given after the occurrence of any the events specified as under:-

If, as a result of force majeure, the contractor are unable to perform specified work for a period of not less than sixty (60) days.

2.6.3 Payment upon Termination

Upon termination of this contract pursuant to clause 2.6.1 or 2.6.2, the **Engineer-in-charge** shall make the following payments to contractors:

- (a) Remuneration pursuant for work satisfactorily performed prior to the effective date of termination;

3. Obligations of the contractors:

3.1 General

This contractor shall perform the work and carry out their obligation hereunder with all the due diligence, efficiency and economy, in accordance with generally accepted professional techniques and practices, and shall observe sound management practice, and employ appropriate advanced technology and safe methods. The contractor shall always act, in respect of any matter relating to the contract as faithful advisers to the Engineer Incharge, and shall at all time support and safeguard the **Engineer-in-charge** legitimate interests of Govt.

3.2 Conflict of interest:

3.2.1 Contractor Not to Benefit from Commissions Discounts, etc.

The remuneration of the contractor shall constitute the Contractor sole remuneration in connection with this contract and the **Engineer-in-charge** shall not accept for his own benefit any trade commission. Discount or similar payment in connection with activities pursuant to this contract or in the discharge of their obligations under the contract, and the contractor shall use their best efforts to ensure that their personnel, contractor, and agents of either of them, similarly shall not receive any such additional remuneration.

3.2.2 Prohibition of conflicting Activities;

The Contractor should not involve either directly or indirectly, in any of the following activities:

- (a) During the term of this contract, any business or professional activities in the government's country which would conflict with the activities assigned to them under this contract or

- (b) After the termination of this contract, such other activities as may be specified in the Sc.

3.3 **Confidentiality:**

The Contractor shall not, either during the term or within two (2) years after the expiration of this contract, disclose any proprietary or confidential information relating to the project, the work and this contract, without the prior written consent of the **Engineer-in-charge**.

3.4 **Contractor's action requiring Engineer-in-charge permission :**

The contractor shall obtain the **Engineer-in-charge** prior approval in writing before taking any of the following actions:

- (a) Entering into a subcontract for the performance of any part of the work.
- (b) Any other action that may be specified in the SC.

3.5 **Documents prepared by the contractor to be the property of the Engineer-in-charge:**

All plans, drawings, specification, designs reports and other documents and software submitted by the contractor shall become and remain the property of the **Engineer-in-charge**.

4. **Obligations of the Engineer-in-charge :**

4.1 **Assistance and exemption**

The **Engineer-in-charge** shall use its best efforts to ensure that the government shall provide the contractor such assistance and exemptions as specified in the SC.

4.2 **Change in the Applicable law**

If, after the date of this contract, there is any change in the applicable law with respect to taxes and duties which increases or decreases the cost of services rendered by the contractor, then the remuneration and reimbursable

expenses otherwise payable to the contractor under this contract shall be increased or decreased accordingly by agreement between the parties, and corresponding adjustments shall be made to the ceiling amount referred to in clause 5.2 as the case may be.

5 Payment to the Contractor/Agency/Firm:

5.1 Lump sum remuneration:

The contractor's total remuneration shall not exceed the contract price and shall be a fixed lump sum including all staff costs, sub-contractors costs, printing, communications, travel accommodation, and the like, and all other costs incurred by the contractor in carrying out the work except the contract price may only be increased above the amount stated the parties have agreed to additional payments.

5.2 Contract Price:

The price payable in local currency is set forth in the SC (Special Condition)

5.3 Terms and conditions of Payment:

Payments will be made to the account of the contractor according to the payment schedule stated in the SC. The extent of the payment shall be made to the contractor/agency/firm for the specific work carried out and not as whole as referred to in TOR.

5.3.1 Bill to be submitted: -

A bill shall be submitted by the contractor each month for all work executed in the previous month and the Engineer-in-charge shall take the requisite measurement, for the purpose of having the same verified and the claim as far as admissible, adjusted, if possible before the expiry of ten days from the presentation of the bill.

The bill shall be submitted by the contractor per month or as per progress of work.

However, no claim on account of delay in payment, which might occur due to reasons beyond the control of the department, shall be entertained.

Whereas such delay of payment effecting progress of work thus effecting date of completion of work, is allowed as per actual circumstances.

The detail schedule approved by the **Chief Engineer, Minimata (Hasdeo) Bango Project, Bilaspur** shall form part of the tender. The payment shall be released only as per work done and respective component of work has been completed and/or levels are achieved.

Contractors shall record the joint measurements for work carried out as per procedure laid down by department for purpose of keeping record and same shall be got checked from competent authority before payment. All hidden measurement shall be got 100% checked from the competent authority before payment

5.3.2 **Alterations in Specifications and Designs:** -

Planner/Designer (The execution company in this case) and Engineer-in-charge shall have power to make any alterations in, or omissions from, addition to, or substitutions for the original specifications, drawings, designs and instructions that may appear to them to be necessary or advisable during the progress of the work and the Contractor shall be bound to carry out the work in accordance with any instruction which may be given to him in writing signed by the Engineer - in - charge and such alterations omissions , additions or substitutions shall not invalidate the contract and any altered, additional or substituted work which the Contractor may be directed to do in the manner above specified as part of the work, shall be carried out by the Contractor on the same conditions, in all respects on

which he agreed to do the main work and at the same rates as mentioned in contract.

5.3.3.Extension of time in consequence of alterations -

The time for completion of the work shall be extended in the proportion of the altered, additional, or substituted work to the original contract works, and the certificate of the Engineer-in -charge shall be conclusive as to such proportion.

6. Settlement of Disputes

6.1 Amicable settlement:

The parties shall use their best efforts to settle amicably all disputes arising out of or in connection with this contract or its interpretation.

6.2 Dispute Settlement:

Any dispute between the Parties as to matters arising pursuant to this contract that cannot be settled amicably within thirty (30) days after receipt by one party of the other party's request for such amicable settlement may be submitted by either party for settlement in accordance with the provisions specified in the SC.

6.3 Advance on plant & Machinery/Mobilization Advance: -

[A] (Applicable for Tenders of Rs. 25 Lakhs or more). An advance for plant and Machinery required for the work and brought to site by the contractor shall be given if requested by the contractor. The maximum of such advance shall be **5%** of the price of the contract amount. In case of new plant and equipment, the advance shall be limited to 90 percent of the price of such new plant and equipment already paid by the contractor, for which the contractor shall produce satisfactory evidence. In the case of used plant and

equipment, amount of such advance shall be limited to 50% of the depreciated value of plant and equipment as may be determined by the Superintending Engineer. These advances shall bear 14% Interest per annum. These advances shall be further, subject to the condition that such plant equipments are: -

- (a) Considered by the Engineer-in-charge to be necessary for the works.
- (b) In working order and
- (c) Hypothecated to the Government, in the form prescribed.

[B] **Mobilisation advance:**

Mobilisation advance not exceeding 5% of contract amount shall be given if requested by the contractor in writing within three month from the date of order to commence the work. In such a case a irrevocable Bank Guarantee from Nationalized Bank for the amount shall be furnished by the contractor before sanction of advance. This advance shall bear interest @ 1% above to the current reserve Bank of India interest rate at the time of payment of advance. The irrevocable Bank Guarantee shall be furnished in the prescribed form appended as “Annexure-L”

6.3.1 Recovery of advance: -

The recovery of the advances granted under clauses 6.3 along with interest shall be made from the running bills in equal installments, equal to the total number of months of the time left for the completion of contract i.e. the advance will be recovered from the first running bill after the issue of advance and shall be fully recovered from the last but one running bill.

7 Escalation Cost : -

No escalation will be paid to the contractor.

8 Compensation for delay :-

The time allowed for carrying out work as entered in the tender shall be strictly observed by the contractor and shall be reckoned from the date on which the order to commence the work is given to the contractor. The work shall throughout the stipulated period of the contract be proceeded with all due diligence (time being deemed to be the expense of the contract on the part of the contractor) and the contractor shall pay as compensation an amount equal to one percent or such smaller amount as the Executive Engineer/Superintending Engineer/Chief Engineer may decide, on the amount of estimated cost of the whole work as shown in the tender for every day that the work remain uncompleted or unfinished after the proper dates. And further, to ensure good progress during the execution of the work the contractor shall be bound in all cases in which the time allowed for any work exceeds one month to complete one sixth of the whole of the work before one fourth of the whole time allowed under the contract has elapsed two fifth of the work before one half of such time has elapsed and three fourth of the work before three fourth of such time has elapsed. In the event of the contractor failing to comply with this condition he shall be liable to pay as compensation an amount equal to one percent or such smaller amount as the Executive Engineer/Superintending Engineer/Chief Engineer may decide on the said estimated cost of the work whole work for every day that the due quantity of the work remains incomplete provided always that the entire amount of compensation to be paid under the provisions of this clause shall not exceed one percent of the estimated cost of the work as shown in the tender.

- 2.** The date on which this contract shall come into effect is:

2.1 The date for commencement of work is immediately after the date of effectiveness of the contract.

2.2 The period shall be 11 (Eleven) from the date of issue of work order including rainy season.

3. The risks and the coverage shall be;

- (1) Third party motor vehicle liability insurance as required under Motor Vehicles Act, 1988, in respect of motor-vehicles operated in India by the contractor/ agency/ firms or their personnel or any sub-contractor or their personnel, for the period of contractor/agency/firms;
- (2) Third party liability insurance, with a minimum coverage for Rs.30.00 Lakhs.
- (3) **Engineer-in-charge** liability and workers' compensation insurance in respect of the personnel of the contractor/agency/firms in accordance with the relevant provisions of the applicable law, as well as with respect to such personnel, any such life, health, accident, travel or other insurance as may be appropriate;
- (4) Professional liability insurance, with a minimum coverage equal to total contract value for this contractor/agency/firms and
- (5) Insurance against loss of or damage to (i) Equipment purchased in whole or in part with funds provided under this contract, (ii) The contractor/agency/firms property used in the performance of the works, and (iii) Any documents prepared by the contractor/ agency/ firms in the performance of the works.

4. Payment shall be made according to following schedule:

- (i) The detail schedule approved by the **Chief Engineer, Minimata (Hasdeo) Bango Project, Bilaspur** shall form part of the tender. The payment shall be released only as per work done and respective component of work has been completed and/or levels are achieved.

- (ii) Three Point Seven Five Percent (3.75%) of contract price bid shall be paid @ 0.75% every year as maintenance cost after completion of work (date of issuing completion certificate) for five consecutive year.

5. Dispute Settlement :

- 5.1 Except where otherwise specified in the contract, for the claim valued less than Rs.50,000/- the decision of the Superintending ; Engineer of the circle or any Superintending Engineer authorized by the Chief Engineer under his jurisdiction for the time being, in respect of all questions and disputes relating to the meaning of the specifications, designs, drawings and instruction herein before mentioned and as to the quality of workmanship or materials used on the work or as to any other questions, claim, right matter or thing whatsoever, in anyway arising out of or relating to the contractor, designs, drawings, specifications, estimates, instruction, order or those conditions or otherwise concerning the work of execution of failure to execute the same whether arising during the progress of the work or after the completion or abandonment thereof shall be final, providing that the Superintending Engineer before giving his decision in writing in the matter, gives an opportunity of being heard to the parties to contract.
- 5.2 If any party of the contract is dissatisfied with the final, decision of the Superintending Engineer in respect of any matter, he may with in 28 days after receiving notice of such decision, give notice in writing to the Superintending Engineer, requiring that the matter may be referred to Arbitration and furnishing details particulars of the dispute or difference and specifying clearly the points at issue. If any party fails to give such notice within the period of 28days as stipulated above, the decisions of the Superintending

Engineer already given shall be conclusive, final and binding on all the parties.

5.3 In case Arbitration is to be held, it shall be affected by the Chief Engineer, whose decision shall be conclusive, final and binding on all the parties.

6. The contractor/agency/firms shall not use these documents for the purposes unrelated to this contract without the prior written approval of the **Engineer-in-charge**.

7. **Construction Programme:-**

The contractor will submit "Construction Programme" showing quantity wise sequence of operations within one week of final approval of design/ drawing/ estimates by competent authority and should get the programme approved from the competent authorities. Along with the above, he will also submit programme of bringing requisite tools and plant, machinery to be engaged by him to the site of work.

Contractor shall also prepare their own month wise (detailed week wise), item wise physical construction programme, prepared with computer aided project management software to generate bar chart based on network technique or improved technique as per approved quantities of different item without modifying date of work order (start date) and stipulated date of completion (end date) within one week after approval of estimate and get it approved from Engineer-in-Charge. The programme shall be as per work completion schedule.

8. **Removal of temporary work, Plant and Surplus Materials:-**

Prior to final acceptance of the completed work, but excepting as otherwise expressly directed or permitted in writing, the contractor shall, at his own expenses, remove from the site and dispose of all the temporary structures including building, piece work, crib work, all plant and surplus materials and all rubbish and debris for which he is responsible to the satisfaction of Engineer-in-Charge.

9. Possession prior to completion:

The Engineer in charge shall have the right to take possession of, or use any completed part of the work, such possession or use shall not be deemed to take the right, as an acceptance of any work not completed in accordance with the contract.

10. Damage to Works:

The works whether fully completed or incomplete, all the materials, machinery, plants, tools temporary buildings and other things connected there with, shall remain at the risk and in the sole charge of the contractor until the completed work has been delivered to the Engineer-in-charge & till completion certificate has been obtained from the Engineer-in-charge.

11. Safety Regulations:-

While carrying out this work, the contractor shall ensure compliance of all safety regulations as provided in safety code.

The contractor shall arrange for the safety in his operations as required including the provisions in the safety manual published by the Central Water and Power Commission, New Delhi (Jan. 1962 Ed.) in case the contractor fails to make such arrangement, the Engineer-in-charge shall be entitled to cause them to be provided and to recover the cost thereof from the contractor.

12. Arrangement for water, power, light :

The Contractor will Arrange :-

12.1 Required electricity connection (dedicated to garden being developed) on site one point (allocated as per plan and design as per requirement).

12.2 The regular payment to C.S.E.B. for the uses of electricity/power on site for landscape development and maintenance purpose.

12.3 Required pump room for electrical panel and operator on the Peripheral area to be developed.

12.4 Distribution of water electricity in site the plot of developed area is a responsibility of contractor (as per design requirement).

13. Regulations and Bye-laws:-

The contractor shall conform to the regulations, bye-laws, any other statutory rules made by any local authorities or by the Government and shall protect and indemnify Government against any claim or liability arising from or based on the violation of any such laws, ordinance, regulations, orders, decrees, etc.

14. Period and hours of work:-

The work shall be done usually during the daytime. In the interest of the progress, if it is felt necessary to work during night, the contractor shall obtain specific permission of the Engineer-in-Charge. If the work is to be done at night, prior permission of Engineer-in-charge should be obtained and adequate lighting arrangement shall be made as directed by the Engineer-in-Charge.

15. Order Book:-

An order book shall be kept in the department office on the site of the work. As far as possible, all orders regarding the works are to be entered in the book. All entries herein shall be signed by the departmental officers in direct charge of the work and contractor or his representatives. In the important cases, the Executive Engineer or the Superintending Engineer will countersign the entries which have been made. The order book shall not be removed from works site except with the written permission of the Superintending Engineer and the contractor or his representative shall be bound to take note of all instructions meant for the contractor as entered in the order book without having to be called for separately to note them. The Engineer-in-Charge shall submit periodically copies of the remarks of the order book to the Superintending Engineer and Chief Engineer for record and to the contractor for compliance and report.

16. Non Drawl of Agreement:-

In the event of tender withdrawing his/her offer before the expiry of the period of validity of offer or failing to execute the contract agreement, as required by conditions of Tender Document, he/she will not be entitled to tender for this work in case of recall, in addition to forfeiture of his/her earnest money, as per provision of the condition of Tender Document. If the tenderer has committed a similar defaults on an earlier occasion as well, his/her registration in the department may be suspended temporarily for a period of 6 months from such date as may be ordered by the competent authority which had registered him/her.

17. Default by the Contractor:-

If the contractor shall neglect or fails to proceed with works with due diligence or he violated any of the provisions of contract, the **Engineer-in-charge** may give the contractor a notice identifying deficiencies in performance and demanding corrective action. After such notice is given, the contractor shall not remove from the site, any plant, equipment and material. The Government shall have lien on all such plant, equipment and materials, from the date of such notice, till the deficiencies have been corrected. If the contractor fails to take satisfactory corrective action within fourteen days after receipt of the notice, the Executive Engineer will terminate the contract in whole or in part, in case the entire contract is terminated, the amount of security deposit together with the value of the work done but not paid for, shall stand forfeited to Government.

The plant equipment and materials held under lien shall then be at the disposal of the Government.

The Executive Engineer may also take possession of the whole or part of the works, site, plant, equipment and materials brought or placed thereon and cause the whole or part of the works, completed by utilizing them through such agencies, at the cost of the contractors. In such cases, the value of the work done through such agencies shall be credited to the contractor at his contract prices. On completion of such work, if the expenses incurred for carrying out such work as certificate by the Executive Engineer are in excess of the value of the work credited to the contractor shall pay the difference to Government. He shall also be liable for the liquidated damages under the contract.

The Executive Engineer may direct that a part or the whole of such plant, equipment and materials are to be removed from the site within a stipulated period. If the contractor fails to do so, the Executive Engineer may cause them to be sold, holding the net proceeds of such sale to the credit of the contractor. After completion of the work and settlement of the amount the loan by the government on the contractor's plant, equipment and balance of materials shall be released. Termination of the contract either in whole or in part shall be adequate authority for the Executive Engineer to demand discharge of the obligations from the guarantors of the security performance.

- 18. Final Certificate :-** On completion of the work the contractor shall be furnished with a certificate by the Engineer-in-charge of such completion, but no such certificate shall be given nor shall the work be considered to be complete, until the contractor shall have removed from premises on which the work shall be executed, all scaffolding surplus materials and rubbish and cleaned off the dirt from all wood work, doors, windows, walls, floors, other parts of any building or structure in, upon or about which the work is to be executed or of which he may have had possession for the purpose of the execution thereof nor until the work shall have been measured by the Sub Divisional Officer, Executive Engineer (Here in after called Engineer-in-charge) whose measurement shall be binding and conclusive against the contractor. If the contractor shall fail to comply with the requirement of this clause such as removal of scaffolding. Surplus materials and rubbish and clearing off dirt, on or before the date fixed for the contractor, remove such scaffolding, surplus materials and rubbish and dispose off the same as he thinks fit and clean off such dirt as aforesaid and the contractor shall forthwith pay the amount of all expenses so incurred and shall have no claim in respect of any such scaffolding or surplus materials as aforesaid except for any sum actually realized by the sale thereof.

However, the contractor shall retain men, material and machinery etc. required for operation and maintenance for complete period of maintenance.

Maintenance period will commence from the issued of completion certificate of construction work by the Executive Engineer.

APPENDIX – F

MODEL RULES RELATING TO LABOUR, WATER SUPPLY AND SANITATION IN LABOUR CAMPS

Note :-These model rules are intended primarily for labour camps which are not of a permanent nature. They lay down the minimum desirable standard, which should be adhered to standard in permanent, or semi permanent labour camps should not obviously be lower than those for temporary camps.

- 1 Location : The camp should be located in elevated and well drained ground in the locality.
- 2 Layout : Labour huts to be constructed for one family or 5 persons each. The layout to be shown in the prescribed sketch.
- 3 Hutment facility : This huts to be built of local materials, Each hut should provide at least 20sq. meter of living space.
- 4 Sanitary Facilities : There shall be provided latrines and urinals at least 16 meter away from the nearest quarter separately for men and women, specially so marked on the following scale.
- 5 latrines: Pit privies at the rate of 10 users families per seat, separate urinals are not required as the privy can be used for this purpose.
6. Drinking Water: Adequate arrangements shall be made for the supply of drinking water. It practicable, filtered and chlorinated supply shall be arranged. Where supply is from intermittent. Sources, a covered storage tank shall be provided with a capacity of five liters per person per day. Where the supply is to be made from a well, it shall conform to the sanitary standards laid down in the report of the Rural Sanitation, Committee. The well should be at least 30 meter away from any latrine or other sources of pollution. If

possible, hand pump should be installed for drawing the water from well. The well should be effectively disaffected once every month and quality of water should be got tested at public Health Institution between each work of disaffection. Washing and bathing should be strictly prohibited at piece where water supply is from a river. The daily supply must be disinfected in the storage reservoir and given at least 3 minutes contact with the disinfectant before it is drawn for use.

7. Bathing and Washing: Separate bathing and washing places shall be provided for men and women for every 25 persons in the camp. There shall be gap and space of 2Sqm. of washing and bathing. Proper drainage for the water should be provided.
8. Waster Disposal: Dustbins shall be provided at suitable places in camp and the residents shall be directed to throw all rubbish in to these dustbins shall be provided with covers. The contents shall be removed every day and disposed of by trenching.
- 9 Medical Facilities:
 - a Every Camp where 1000 or more persons reside be provided with whole time Doctor and Dispensary. If there are women in the camp, a whole time Nurse shall be employed.
 - b Every camp where less than 1000 or more than 250 persons reside shall be provided with a Dispensary and a part time Nurse / Midwife shall also be employed.
 - c If there are less than 250 members in any camp, a standard first aid kit shall be maintained in charge of the whole time person, trained in first aid. All the medical facilities mentioned above should be for all residents in the camp, including the dependants of workers, if any, free of cost.
- 10 Sanitary Staff: For each labour camp there should be qualified Sanitary Inspector and Sweepers. Sweepers should be provided on following scale:-

1	For Camps with strength over 200. But not exceeding 500 persons	One sweeper for 75 persons above the first 200 for which three sweepers be provided
2	For camps with strength over 500 Persons	One sweeper for every 100 persons above the first 500 for which six sweeper should be provided.

APPENDIX – G

FAIR WAGES TO LABOUR

The contractor shall pay not less than FAIR WAGE to labour engaged him on the work.

Explanation:-

- a “Fair Wage” means wage whether or any time or piece work as notified at the time of inviting tenders for the work and where such wages have not been so notified, the wages prescribed by the Water Resources Department for the division in which the work in done.
- b The contractor shall, not with standing the provisions of contract, to the contrary, cause to be paid a fair a fair wage to laborers indirectly engaged on the work, including and labour engaged by his sub-ordinates in concoction with the said work, as if the labours had been immediately employed by him.
- c In respect of labour directly or indirectly employed on the work for the performance of the contractors part of this agreement the contractor shall comply with or cause to be complied with the labour act in force.
- d The Executive Engineer / Engineer-in-charge shall have the right to deduct from the moneys due to the contractor any sum required for making good the loose certified by.
- e The contract of shall be primarily liable for all payments to be made under and for the observance of the regulations aforesaid without prejudice to his right to claim indemnity from his sub-contractor.
- f The regulations aforesaid shall be deemed to be part of this contract, and any breach thereof shall be deemed to be a breach of contract.

g The contractor shall obtained a valid license the contract labour (Regulation and Abolition) Act. Enforce and rules made there under by the competent authority from time to time before commencement of the work and continue to have a valid license until the completion of the work.

Any failure to fulfill this requirement shall attract the panel provisions of this contract arising out of this as resulting in non-execution of the work assigned to the contractor.



संदर्भ :- माननीय मंत्रीजी जल संसाधन विभाग द्वारा दिनांक 24.03.2017 को दिये गये निर्देश।

उपरोक्त विषयान्तर्गत जल संसाधन विभाग द्वारा केलो बांध के परिक्षेत्र को विकसित करने हेतु प्रदत्त प्रशासकीय स्वीकृत रु. 680.47 लाख के अंतर्गत निम्नानुसार प्रावधान हेतु निर्देशित किया गया:

(अ) केलो बाँध परिक्षेत्र के अधिग्रहित भूमि की सुरक्षा हेतु भूमि के किनारे 40 प्रतिशत लंबाई में बाउन्ड्रीवाल का निर्माण तथा शेष लंबाई में बारवेड वायर फेंसिंग के वर्तमान प्रस्ताव के स्थान पर पूरी लंबाई में बाउन्ड्री वाल का निर्माण निविदा के माध्यम से कराया जावे।

(ब) केलो नदी के पुराने मार्ग के दोनों तट पर पिचिंग निर्माण, घाट निर्माण तथा वाटर बाडी निर्माण एवं केलो बाँध के नीचे के पूरे परिक्षेत्र में (वर्तमान पर्यावरणीय व पारिस्थितिकी कार्य को छोड़कर) सौंदर्यीकरण, लैण्ड स्केपिंग आदि का कार्य रुचि की अभिव्यक्ति (EOI) के माध्यम से कराया जावे।


(स) बाँध स्थल पर निर्मित कंट्रोल रुम के उपर 03 नग सुईट के निर्माण से संबंधित ड्राईंग का अवलोकन करने पश्चात इसमें उनके द्वारा कुछ संशोधन बताया गया तथा संशोधन उपरांत कार्यको निविदा के माध्यम से कराया जावे।

(द) वर्तमान कंट्रोल रुम के सामने हाई मास्ट लाइट व कंट्रोल रुम की सुरक्षा हेतु बाँध के जल भराव क्षेत्र की तरफ रिप रेप पिचिंग का कार्य विभागीय परियोजना मद अंतर्गत निविदा से कराया जावे।

उपरोक्त निर्देशों के तारतम्य में मुख्य अभियंता, मिनीमाता बांगो परियोजना बिलासपुर द्वारा अपने पत्र क्र. 1528/65/कार्य/एम./83/पार्ट III "B"/बिलासपुर दिनांक 04.03.2017 से प्रदत्त तकनीकी स्वीकृति रु. 343.21 लाख के लिये आमंत्रित की गई निविदा को निरस्त किया जाने हेतु अनुमति की आवश्यकता है।

2. संभागाधीन कार्यों की प्रगति की जानकारी मांगे जाने पर अधोहस्ताक्षरकर्ता द्वारा बताया गया कि मुख्य नहर के आर.डी. 300 मी. से 4320 मी. के मध्य विभिन्न स्थानों पर पहाड़ से वर्षाजल के साथ बहकर आई हुई मिट्टी आर.डी. 4320 मी. से 8070 मी. के मध्य रेनकट एवं लाईनिंग के दौरान एकत्रित अतिरिक्त मिट्टी के नहर तल में जमा होने के कारण रूपांकित जलप्रवाह क्षमता 22.924 क्यूमेक्स प्रवाहित किया जाना संभव नहीं हो पाता है। 4 से 6 क्यूमेक्स जलप्रवाह होने पर पूर्ण जलप्रवाह प्रतीत होता है एवं कई स्थानों पर नहर तटबंध टूटने की स्थिति में आ जाते हैं। इस हेतु नहर तल पर जमा सिल्ट को हटाने हेतु प्राक्कलन राशि 432.47 लाख का मुख्य अभियंता कार्यालय में प्रस्तुत किया गया है। आर.डी. 8070 मी. से 10500 मी. के मध्य नहर तल की गहराई 8 से 12 मी. के मध्य है। पूर्व स्वीकृत प्राक्कलन में बर्म का प्रावधान न होने के कारण कई स्थानों पर मिट्टी घसककर नहर तल में जमा हो गई है। इस रिच में बर्म बनाये जाना आवश्यक है। इस बाबत प्राक्कलन राशि 206.73 लाख का मुख्य अभियंता कार्यालय को प्रस्तुत किया गया है। माननीय मंत्रीजी महोदय द्वारा नहरों का सुधार कार्य वर्षा पूर्व कराया जाकर रूपांकित जलप्रवाह आगामी खरीफ सीजन में प्रवाहित करने हेतु निर्देशित किया गया।
3. लंबित भू-अर्जन प्रकरणों के त्वरित निराकरण कर अवार्ड प्राप्त करने हेतु निर्देशित किया गया तथा शेष भू-अर्जन प्रकरण यथाशीघ्र प्रस्तुत करने हेतु निर्देशित किया गया। शेष नहरों के निर्माण हेतु विशेष प्रयास करने हेतु निर्देशित किया गया।
4. केलो बांध के नीचे परिक्षेत्र में निर्मित पर्यावरणीय कार्य का समुचित रखरखाव एवं सुरक्षा व्यवस्था किये जाने हेतु वार्षिक रखरखाव के प्रस्ताव/प्राक्कलन प्रस्तुत करने हेतु निर्देशित किया गया।
- उपरोक्त वस्तुस्थितिगत तथ्यों के आधार उपरोक्त अ से द तक के प्राक्कलन प्रस्ताव शीघ्र ही प्रस्तुत किये जावें।
- सूचनार्थ एवं आवश्यक कार्यवाही हेतु संप्रेषित।


